



## **Communication and People Skills at Executive Level (SE1) Examination** **November 2019**

The written examination of Communication and People Skills at Executive Level (SE1) will be held on 17<sup>th</sup> November 2019 in Colombo. This Examination will be conducted in two parts.

Part I - Written examination for testing Reading, Writing and Listening skills.

Part II – Speaking examination

Two separate admission cards will be issued for part I and II. Date/time of the speaking test will be notified in the speaking admission card. It is compulsory to complete both, part I and II at the same examination.

Please indicate “**SE1 Examination – November 2019**” on the top left-hand corner of the envelope.
  - All students who apply for the SE1 exam for the **first time should have at least 75% attendance for the SE1 course conducted by an approved teaching college**. Students who have been exempted from the course are requested to attach the confirmation of results along with their exam application form.
  - Examination fee for SE1 Examination is **Rs. 2,500.00**. The fee could be paid to any Bank of Ceylon branch / at the CA Cashier or online payment through the student profile.
