Arrangements for Council Elections – 2021

In terms of Clause 6(3) of the Institute of Chartered Accountants (Elections) Order, 1969, I am enclosing herewith three lists containing the names in alphabetical order of the persons duly nominated for the posts of President, Vice President and Members of Council, for the term 2022/2023.

The Meeting of the Members of the Institute for the purpose of electing the Vice President and six Members to the Council will be held on **Friday, 17th December 2021 at 1:00 pm** at the Institute of Chartered Accountants of Sri Lanka, No. 30A, Malalasekera Mawatha, Colombo 07.

In view of the large number of Members expected, the following steps have been taken to ensure the smooth conduct of the CA Sri Lanka Council Elections 2021.

1. **Time Allocated for Voting** – Registration of Members for voting will open from **1:00 pm to 7:00 pm** and voting will cease at 7:30 pm. Members are advised to arrive at the Institute early and cast their votes. Please note that Members will not be permitted to enter the Institute premises after 7:00 pm. Further, Members are also advised to **leave the Institute premises immediately** after casting their votes, as per the instructions issued by the PHI in line with the COVID-19 health guidelines.
2. **Parking Facilities and Shuttle Service** – Parking will be available at the CMC public car park located in front of the Institute, as well as at the BMICH car park and the CR&FC car park. Please note that we have also arranged for a shuttle service to the Institute from the BMICH car park and the CR&FC car park. 3. **Direction to the Registration / Voting Area** – Registration / Voting Counters will be placed at the Main Hall on Level 1. You may use the entrance of the CA Sri Lanka Car Park to proceed to the registration counters.
4. **Registration** - For your convenience, the Registration Counters on Level 1 will be allocated according to the membership numbers of the Members. For the convenience of our senior Members, a priority queue has been set up for those holding membership numbers up to 1500.

In order to ensure a smooth registration process, you are kindly requested to be familiar with your membership number and to also have with you the National Identity Card or Passport or Driving License ready for mandatory identity verification purposes. Due to the health and safety precautions, we advise you to bring your own pen to cast your vote.

Please note that only active members as at 17 December 2021 will be eligible to cast their vote at the election. Members who have not renewed their membership for the year 2021 on or before 15 December 2021 are not eligible to vote at the election.
