



SESSION 6: SERVICE INNOVATION (DISCUSSION FORUM)

Synopsis

In spite of the increasing importance of the service sector, which is now of major importance in many countries of the world, the issue of how to stimulate and manage innovation in the service sector remains a conundrum. In the service sector, customer interaction plays a key role apart from the product itself. Therefore, innovation in service companies is not only about "what" is being offered but also about "how" it is being offered in order for it to be accepted by the customer. Consequently in the service sector improving on the innovation performance has been an integral part of their business strategy and in crafting a distinctive competitive advantage. The panel discussion would identify how innovation impacts various sectors of the service industry, including financial services. In today's highly competitive environment, innovation has become inevitable to create value and spur growth. However, additional value may not be able to create through innovation always or may not be commercially viable. Therefore, the risk of failure is an inherent aspect of innovation. The success of innovation depends on the design skills of its engineers, upon the effectiveness with which it can mobilize, apply, and develop its distinctive knowledge as circumstances change. Identifying, analysing and managing these risks (market, technology, environment, and organisation related risks) will lead to effective decision making in various innovation projects. How best organisations manage innovation will be dependent on how best they manage the associated risks. The focus of this session will be the role of professionals in innovation process and particularly in managing risk aspect.
